RESOLUTION NO. 564-2022

DECLARING MUNICIPAL ORDINANCE NO. 03, S-2022 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED “AN ORDINANCE PENALIZING THE EXPLICIT MISREPRESENTATION OF ONE’S STATUS BY PANTAWID PAMILYANG PILIPINO PROGRAM (4P’S) BENEFICIARIES WITHIN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Municipal Ordinance No. 03, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (b) (2) (iv) and 447 (a) (1) (iii) (5) (xiv) of R.A. No. 7160 and Republic Act No. 11310, otherwise known as the “Pantawid Pamilyang Pilipino Program (4Ps) Act”;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) R.A. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—
