PROVINCIAL RESOLUTION NO. 450-2014

**URGING THE LEAGUE OF PROVINCES TO ENCOURAGE
ALL PROVINCES TO ESTABLISH THEIR RESPECTIVE
PROVINCIAL OVERSEAS FOREIGN WORKERS' DESK**

WHEREAS, the Province of Pangasinan has effectively and favorably implemented Provincial Ordinance No. 149-2011 entitled "An Ordinance for the Establishment of a Pangasinan Overseas Foreign Workers' Desk (*Annex "A"*) since 2011;

WHEREAS, after finding the same to be impressive, operative and effective program of the Province of Pangasinan to most OFWs and their families, the Provincial Government finds it necessary and desirable to share the same program with the other provinces in the country;

WHEREAS, the Province of Pangasinan is inclined to seek the intervention of the League of Provinces to encourage and assist all the provinces nationwide for the establishment of their respective Provincial OFWs Desk in order to protect the interest of OFWs in their local government units;

WHEREFORE, on motion of SP Members Ranjit R. Shahani and Angel M. Baniqued, Jr., duly seconded, it was –
