**RESOLUTION NO. 203-2022**

**DECLARING ORDINANCE NO. 38, S-2021 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO COLLEGE STUDENTS FROM THE MUNICIPALITY OF ASINGAN, PANGASINAN IN THE AMOUNT OF FIVE THOUSAND PESOS (P5,000.00) EACH PER SEMESTER TO QUALIFIED INDIGENT BUT DESERVING COLLEGE STUDENTS WHO ARE ENROLLED AT ANY PANGASINAN STATE UNIVERSITY (PSU) CAMPUS, URDANETA CITY UNIVERSITY (UCU) AND UNIVERSITY OF EASTERN PANGASINAN (UEP)” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**
