RESOLUTION NO. 488-2022

DECLARING ORDINANCE NO. 171, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE PROGRAMS, SERVICES, PRIVILEGES AND BENEFITS FOR SOLO PARENTS AND THEIR CHILDREN, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES PURSUANT TO REPUBLIC ACT 8972, KNOWN AS THE SOLO PARENTS ACT OF 2000" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 171, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 16 and 17 (b) (2) (iv) of R. A. No. 7160, R.A No. 8972 otherwise known as "An Act Providing for Benefits and Privileges to Solo Parents and Their Children, Appropriating Funds Thereof and for Other Purposes" and Memorandum Circular No. 08, S-2004 of the Civil Service Commission;

WHEREAS, however, the programs, projects and activities (PPAs) enumerated should be included in the GAD Plan of the Municipality;


