**RESOLUTION NO. 559-2022**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2022 OF SAN MANUEL, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P2,593,551.00, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2022 involving total appropriations of P2,593,551.00, which was enacted on February 9, 2022 through Appropriation Ordinance No. 01, Series 2022;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the utilization of appropriation from FY 2018 share of the Municipality from Burley and Native Tobacco Excise Tax Collections shall be subject to the provisions of Local Budget Memorandum No. 83 dated November 22, 2021;
3. That all programs, projects and activities to be implemented are in accordance with the approved CY 2022 Supplemental Investment Program of the Municipality; and
4. That all procurements to be undertaken shall be subject to the provisions of R. A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –


