## RESOLUTION NO. 639-2022

APPROVING RESOLUTION NO. 2022-670 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1, FOR THE CALENDAR YEAR 2022 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its SB Resolution No. 2022-670 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- The Local Development Council of Balungao, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 1 through MDC Resolution No. 2022-02 dated May 23, 2022 to their Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109, 114 of the Local Government Code of 1991;
- 2. The Supplemental Investment Program No. 1 with an investment requirement amounting to Php2,200,000.00 covers fund augmentation for personal services (Terminal Leave Benefits of retiring and end of term municipal officials); and

3. The Sangguniang Bayan enacted Supplemental Budget No. 1 through Appropriation Ordinance No. 2022-01 dated June 1, 2022, to support the implementation of the Supplemental Investment Program No. 1 of the municipality.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao, Pangasinan;
