PROVINCIAL RESOLUTION NO. 752-2022

**AMENDING RULE XI, SECTION 68 (h) OF THE INTERNAL
RULES OF PROCEDURE OF THE 11TH SANGGUNIANG
PANLALAWIGAN OF PANGASINAN (2022-2025) BY
ADDING THE COMMITTEE ON BOUNDARY DISPUTES**

WHEREAS, Section 118 of RA No. 7160 mandates the Sangguniang Panlalawigan to resolve boundary disputes between municipalities within the Province;

WHEREAS, it also provides that boundary disputes between municipalities of adjoining provinces shall be resolved by and between the concerned Sangguniang Panlalawigan;

WHEREAS, Rule XI, Section 68 (h) of the Internal Rules of the 11th Sangguniang Panlalawigan stipulates the creation of the nineteen (19) Standing Committees but there is no specified committee directly and principally involved on all matters relating to all boundary disputes between municipalities within the Province and of adjoining provinces;

WHEREAS, it is the concern of the 11th Sangguniang Panlalawigan to take action on boundary disputes through a Regular Committee and not just an Ad Hoc Committee;

WHEREAS, it is necessary therefore to amend Rule XI, Section 68 (h) of the Internal Rules of Procedure of the Sangguniang Panlalawigan by adding the 20th committee which is the Committee on Boundary Dispute which shall be tasked to conduct hearing/ocular inspection, invite key personalities concerned, undertake studies and evaluation and submit its findings or recommendation on boundary disputes;
