PROVINCIAL RESOLUTION NO. 755-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE UNIVERSITY OF THE PHILIPPINES, LYCEUM-NORTHWESTERN UNIVERSITY, PANGASINAN STATE UNIVERSITY, PHINMA UNIVERSITY OF PANGASINAN, UNIVERSIDAD DE DAGUPAN, UNIVERSITY OF EASTERN PANGASINAN, UNIVERSITY OF LUZON, AND THE VIRGEN MILAGROSA UNIVERSITY FOUNDATION FOR COLLABORATION EFFORTS WITH THE CENTER FOR PANGASINAN STUDIES FOR THE PROMOTION, PRESERVATION AND DEVELOPMENT OF HISTORICAL AND CULTURAL HERITAGE OF PANGASINAN

WHEREAS, the Provincial Government established the Center for Pangasinan Studies as the research and development arm of the Province of Pangasinan through Provincial Ordinance No. 199-2016;

WHEREAS, it is the aim of the Provincial Government, through the Center for Pangasinan Studies, to further strengthen, promote and develop the history and culture of Pangasinan so as to maintain its distinctive place in the society;

WHEREAS, in order to fully realize this notable undertaking, the following premiere Higher Education Institutions (HEIs), namely: University of the Philippines, Lyceum-Northwestern University, Pangasinan State University, Phinma University of Pangasinan, Universidad De Dagupan, University of Eastern Pangasinan, University of Luzon, and the Virgen Milagrosa University Foundation, have signified their willingness as a consortium to identify and conduct research on the Province's history and culture as well as to provide guidance in the policies and programs to be implemented by the Center for Pangasinan Studies;

WHEREAS, further, the specialization of the aforesaid HEIs would significantly help the Center for Pangasinan Studies as they are equipped with resources and capabilities for research and development;

WHEREAS, the Provincial Government recognizes the full support and the role of HEIs as partners geared towards enriching the cultural development of the Province of Pangasinan;

WHEREAS, the duties and responsibilities of the parties including other conditions are stipulated in the Memorandum of Agreement which is made an integral part of this resolution;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between and among the Province of Pangasinan, represented by Honorable Governor Ramon V. Guico III, the University of the Philippines, represented by its President, Danilo L. Concepcion, the Lyceum-Northwestern University, represented by its President, Luz T. Duque-Hammershaimb, the Pangasinan State University, represented by its President, Dexter R. Buted, the Phinma University of Pangasinan, represented by its President, Christopher A. Tan, the Universidad de Dagupan, represented by its President, Voltaire P. Arzadon, the University of Eastern Pangasinan, represented by its President, Evelyn A. Tomboc, the University of Luzon, represented by its President, MacArthur M. Samson, Sr., and the University of Virgen Milagrosa University Foundation, represented by its President, Ma. Lilia Q. Posadas-Juan;

WHEREFORE, on motion of Vice Governor Mark Ronald DG. Lambino, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement between and among the University of the Philippines, Lyceum-Northwestern University, Pangasinan State University, Phinma University of Pangasinan, Universidad De Dagupan, University of Eastern Pangasinan, University of Luzon, and the Virgen Milagrosa University Foundation for collaboration efforts with the Center for Pangasinan Studies for the promotion, preservation and development of historical and cultural heritage of Pangasinan;


