## **RESOLUTION NO. 756-2022**

DECLARING MUNICIPAL ORDINANCE NO. 2022-003 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING THE RENEWAL OF FRANCHISE TO MR. MODESTO B. MELCHOR TO OPERATE AND MAINTAIN A COCKPIT ARENA IN THE MUNICIPALITY OF LAOAC, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Municipal Ordinance No. 2022-003 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (3) (v) of R.A. No. 7160, IATF-EID Guidelines, in particular paragraph (B) sub-paragraph (1) of the Inter-Agency Task Force Resolution No. 154, Series of 2021 dated December 14, 2021 and DILG Memorandum Circular No. 2022-003 entitled: "Guidelines on the Resumption of Cockpit Operations or Cockfighting in Areas under Alert Level 2 or Lower";

WHEREAS, subject ordinance shall take effect after the Sanguniang Bayan has complied with the requirement of posting, public hearing, and publication pursuant to Sections 59 (a), 187 and 188 of Local Government Code of 1991;

WHEREAS, however, the Sangguniang Bayan shall consider the points raised by the Provincial Legal Officer stated in her opinion dated August 23, 2022;
