STANDING COMMITTEE ON BOUNDARY DISPUTES OF THE
INTERNAL RULES OF PROCEDURE OF THE 11TH
SANGGUNIANG PANLALAWIGAN OF PANGASINAN (2022-
2025)**

WHEREAS, the Sangguniang Panlalawigan has approved the amendment of Rule XI, Section 68 (h) of the Internal Rules of the 11th Sangguniang Panlalawigan which stipulates the creation of the nineteen (19) Standing Committees, whereby the Committee on Boundary Disputes was added;

WHEREAS, in order for the new Standing Committee to function, there is a need to determine its composition which shall consist of the Chairman, Vice Chairman and its Members;


