PROVINCIAL RESOLUTION NO. 760-2022

REQUESTING THE LAND TRANSPORTATION, FRANCHISING AND REGULATORY BOARD (LTFRB), TO PUT UP A SATELLITE OFFICE IN THE PROVINCE OF PANGASINAN SPECIFICALLY IN THE CITY OF URDANETA

WHEREAS, the Province of Pangasinan comprising of forty-four (44) municipalities and four (4) cities is the biggest province in Region I;

WHEREAS, the Sangguniang Pangasinan would like to help in addressing the plights of PUV drivers and operators in the Province of Pangasinan particularly in the expeditious and economical way of processing their franchises and other concerns however, an essential agency like the Land Transportation, Franchising and Regulatory Board (LTFRB), does not have a satellite office in the Province;

WHEREAS, there used to be an LTFRB satellite office located at the Astrodome in Dagupan City, but for one reason or another, the said office did not stay long in the said city;

WHEREAS, the putting up of LTFRB satellite office in the Province is of paramount importance for the purpose of catering to the service needs of these drivers and operators whose papers will still have to be processed in La Union and even in Manila, as the case may be,

WHEREAS, a satellite office in Dagupan City will save precious time, effort and money for hundreds of drivers and operators trooping to the LTFRB regional and national offices as the location of LTFRB satellite office will be nearer to them;

WHEREAS, the proposed satellite office in Pangasinan can also reach out and serve neighboring towns of other provinces;


