APPROVING RESOLUTION NO. 134, S-2022 OF THE SANGGUNIAN BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 6, SERIES OF 2022 ENTITLED "RESOLUTION RECOMMENDING APPROVAL OF THE REALIGNMENT/REVERSION OF THE AMOUNT OF SIX MILLION FIVE HUNDRED SIXTY THREE THOUSAND SEVEN HUNDRED SIXTY ONE PESOS (P6,563,761.00) FROM THE PORTION OF THE UNUTILIZED FUND OF THE AIP 2022 AMOUNTING TO TWO MILLION SIXTY THREE THOUSAND SEVEN HUNDRED SIXTY ONE (P2,063,761.00) PREVIOUS ALLOTTED TO ESTABLISHMENT OF LGU CEMETERY AT BARANGAY BUENLAG AND FROM THE SUPPLEMENTAL AIP 2022 AMOUNTING TO FOUR MILLION FIVE HUNDRED THOUSAND PESOS (P4,500,000.00) PREVIOUSLY ALLOTTED TO PURCHASE OF LOT FOR EXPANSION OF CALASIAO CEMETERY AT BARANGAY BUENLAG"




