## **PROVINCIAL RESOLUTION NO. 6-2023**

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE ATENEO DE MANILA UNIVERSITY-INSTITUTE OF PHILIPPINE CULTURE (ADMU-IPC) FOR THE IMPLEMENTATION OF THE OPERATIONAL RESEARCH PROJECT ENTITLED: "LOCAL GOVERNMENT UNIT-MANDATED CHEALTH NETWORKED SERVICES FOR UNIVERSAL HEALTH CARE (UHC LCHNS) IN THE PROVINCE

WHEREAS, the Provincial Government of Pangasinan, through the Provincial Health Office, in collaboration with the Ateneo de Manila University-Institute of Philippine Culture (ADMU-IPC) will continue to undertake the operational research project entitled: "Local Government Unit-Mandated eHealth Networked Services for Universal Health Care (UHC LeHNS) in the Province;

WHEREAS, the UHC LeHNS project is for the development of Universal Health Care-compliant local health information system in order to initiate reforms that would facilitate information exchange between and among health institutions;

**WHEREAS**, the ADMU-IPC aims to assist the Province in continually implementing an interoperable health information system that facilitates easy access to and exchange of local health information between and among the Province's health institutions;

WHEREAS, the Sangguniang Panlalawigan fully supports the program as it gives paramount importance to the role of Information, Communication and Technology (ICT) by conducting capacity building activities through enhanced eLearning programs and health information system aimed to provide technical assistance to rural health units of municipalities and cities within the Province in order to ensure an effective and efficient governance especially in the delivery of basic public health services;
