#### **EXECUTIVE ORDER NO. 02-09-2022**

#### RECONSTITUTING THE PANGASINAN PROVINCIAL CULTURE AND ARTS COUNCIL

**WHEREAS**, the province of Pangasinan is one of the culturally rich and historically colorful provinces of the Philippines, thus it is an integral part of the development thrust of the provincial government of Pangasinan to protect, promote, preserve and develop the history, cultural heritage, and arts of the province;

**WHEREAS,** DILG Memorandum Circular No. 2017-133, entitled "Creation of Local Culture and Arts Council", mandates the creation and establishment of a local culture and arts council in every local government unit in the country;

**WHEREAS,** by virtue of Executive Order No. 0034-2018, issued by the Office of the Governor, Province of Pangasinan, created the Pangasinan Provincial Culture and Arts Council, effective May 22, 2018;

**WHEREAS**, by virtue of Executive Order No. 0126-2021, issued by the Office of the Governor, Province of Pangasinan, reconstituted the Pangasinan Provincial Culture and Arts Council, effective October 11, 2021;

**WHEREAS**, there is again a need to reconstitute the composition of the Pangasinan Provincial Culture and Arts Council to look into matters pertaining to the protection, preservation, promotion, and development of Pangasinan's history, cultural heritage and arts;

**NOW, THEREFORE, I, RAMON V. GUICO III,** Governor, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby reconstitute the Pangasinan Provincial Culture and Arts Council, which shall be composed of the following as prescribed under DILG MC 2017-133:

#### **Functions:**

The Pangasinan Provincial Culture and Arts Council shall perform the functions as stipulated in the *DILG MC 2017-133*, to wit:

# As per DILG Memo Circular No. 2002-81 or The Creation of Local Culture and Arts Council:

- 1. Prepare an annual plan on culture, arts, and cultural heritage consonant with the Philippine Development Plan for Culture and the Arts, to be integrated in the local development plan considered in the annual appropriate ordinances;
- 2. Formulate programs and recommendations to develop and sustain local cultural and artistic talents, cultural industries, traditional and contemporary arts and crafts, and their processes;
- Coordinate with the appropriate affiliated cultural agencies of the National Commission for Cultural and Arts (NCCA) for the conservation and monitoring of national cultural properties found in the LGU;
- 4. Conduct cultural events such as cultural festivals, competition, lectures, seminars and symposia;
- 5. Identify such other programs and activities for the promotion of local cultural heritage and

# As per Republic Act No. 10066 or the National Cultural Heritage Act of 2009:

- 6. Ensure the protection, preservation, conservation and promotion of the local cultural and historical heritage;
- 7. Declare and maintain Local Heritage Zones;
- 8. Establish a Local Registry of Cultural Property;

# As per Republic Act No. 7355 or The Gawad ng Manlilikha ng Bayan Act:

- 9. Acknowledge the importance of traditional folk artist as singular conduit between skills of the past and the future;
- 10. Revitalize a community's artistic tradition thereby protecting a valuable fact of Philippine culture:
- 11. Provide mechanisms for identification and assistance for qualified traditional folk artists to transfer their skills to the community; and,
- 12. Create opportunities for popularizing their works locally.

# Secretariat:

The Provincial Tourism and Cultural Affairs Office (PTCAO) shall provide necessary secretariat support services to the Pangasinan Provincial Culture and Arts Council.

# Effectivity:

The Pangasinan Provincial Culture and Arts Council shall convene upon approval of this order, and shall remain to function until revoked in writing.
