**APPROVING RESOLUTION NO. 2022-131, SERIES OF 2022 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2022-04 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN, FOR CALENDAR YEAR 2022, REQUIRING A TOTAL FUNDING OF SEVEN MILLION, FIVE HUNDRED SEVENTY-ONE THOUSAND PESOS (P7,571,000.00)"**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2022-131, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan prepared the LGU's Supplemental Investment Program (SIP) No. 04, CY 2022. This was endorsed by the Council, through MDC Resolution No. 2022-15, Series of 2022 dated December 21, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental AIP, which has a total investment requirement of ₱7,571,000.00, covers fund augmentation for Personal Services (granting of Service Recognition Incentives (SRI), Collective Negotiation Agreement (CNA) Incentives) and provision of Rice Assistance and gratuity pay for qualified personnel of the LGU; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2022-04, FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-013, Series of 2022 dated December 23, 2022.


