**RESOLUTION NO. 155-2023**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 5 FOR  
CALENDAR YEAR 2022 OF BINMALEY, PANGASINAN  
INVOLVING A TOTAL APPROPRIATIONS OF P1,264,000.00,  
OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Supplemental Budget No. 5 for Calendar Year 2022 involving total appropriations of P1,264,000.00, which was enacted on December 28, 2022 through Appropriation Ordinance No. 6, Series of 2022;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That the grant of Service Recognition Incentive (SRI) to municipal officials, regular and casual employees shall be in accordance with the provisions of Budget Circular No. 2022 - 4 of the Department of Budget and Management dated December 20, 2022; and
3. That the grant of Gratuity Pay to Contract of Service and Job Order Workers in the municipality shall be in accordance with the provisions of Administrative Order No. 03 of the Office of the President dated December 23, 2022.


