APPROVING MUNICIPAL RESOLUTION NO. 2022-280 OF THE SANGGUNANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02 FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF ALCALA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Alcala Pangasinan submitted its SB Resolution No. 2022-280 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Alcala, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 02. This was endorsed to the Sangguniang Bayan for approval on December 28, 2022 by the Municipal Development Council through Resolution No.2022-01;

2. Said SAIP No. 2 of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive to qualified employees), Maintenance and Other Operating Expenses and Capital Outlay of some municipal government offices, and the implementation of disaster risk reduction management programs/projects of the LGU;
3. Funding support for the implementation of the same in the amount of PhP 73,662,946.15 is embodied in their proposed Supplemental Budget No. 2 for Fiscal Year 2022 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2022-03 on December 29, 2022; and
4. The identified projects to be funded from the municipality's FY 2020 shares from Tobacco Excise Tax, which has an investment requirement of P 72,060,844.00 is consistent with Local Budget Memorandum No. 86 dated December 14, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Alcala, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 2022-280 of the Sangguniang Bayan of Alcala, Pangasinan, entitled “Approving the Supplemental Annual Investment Program No. 02 for Calendar Year 2022 of the Municipality of Alcala, Pangasinan”;
