PROVINCIAL RESOLUTION NO. 491-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT AND DATA SOURCING AGREEMENT WITH THE PHILIPPINE OBSTETRICAL AND GYNECOLOGICAL SOCIETY (FOUNDATION), INC. FOR THE DEVELOPMENT OF A NATIONWIDE ELECTRONIC CENSUS PLATFORM FOR THE PANGASINAN PROVINCIAL HOSPITAL

WHEREAS, the Philippine Obstetrical and Gynecological Society (POGS) (Foundation), Inc. is an association of medical practitioners in the field of obstetrics and gynecology in the Philippines, which aims to enhance the professional growth and welfare of its members;

WHEREAS, the Philippine Obstetrical and Gynecological Society (POGS) (Foundation), Inc. has developed an electronic census platform called the POGS (PNSS) to collect the statistical data on obstetric and gynecologic health indicators;

WHEREAS, the Provincial Government of Pangasinan, through the Pangasinan Provincial Hospital (PPH), intends to enter into the Memorandum of Agreement and Data Sourcing Agreement with POGS for the purpose of development of a census application based on POGS PNSS to be deployed to the former;

WHEREAS, the PPH and POGS will work together to develop census application which will be used by PPH facilities to collect census data and which application will anonymize the data before sending the data online to the POGS cloud portal;

WHEREAS, timely and accurate statistics for obstetrical and gynecological indicators of health care in the Province is important in order to help define areas for improvement;



WHEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


