DECLARING ORDINANCE NO. 2022-18 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTILTLED "AN ORDINANCE ENJOINING ALL BUSINESS ESTABLISHMENTS AND LOCAL TRANSPORTATION IN THE CITY OF ALAMINOS, PANGASINAN TO ADOPT QR PH DIGITAL PAYMENTS IN LINE WITH THE PALENG-QR PH PROGRAM" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2022-18 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
