PROVINCIAL RESOLUTION NO. 241-2023

INVITING THE REPRESENTATIVE OF ABOITIZ COMPANY, AND THE CHIEF OF POLICE OF AGUILAR, PANGASINAN TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS MARCH 13, 2023 REGULAR (PHYSICAL) SESSION TO SHED LIGHT ON THE ACCIDENT THAT HAPPENED IN DAANG KATUTUBO IN SITIO MAPITA, BARANGAY LAOAG, AGUILAR, PANGASINAN

WHEREAS, the purpose of this inquiry emanated from a news report that an accident happened on March 2, 2023 in Daang Katutubo in Sitio Mapita, Barangay Laoag in Aguilar, Pangasinan;

WHEREAS, the Sangguniang Panlalawigan would like to know the details particularly those involved in the accident, whether necessary assistance and support were extended to the victims, and whether all necessary caution was taken by involved authorities to avoid such accident;

WHEREAS, the Sangguniang Panlalawigan fully supports the construction of important projects such as the Daang Katutubo Road as it aims to provide transportation and infrastructure support to further boost trade and tourism, however, it is also the desire of the Body to be informed of the actions being undertaken by concerned authorities to solve the issues surrounding the same;

WHEREAS, Section 20 of the Internal Rules of Procedure of the 11th Sangguniang Panlalawigan of Pangasinan provides that a Question Hour is the period of time allotted for members of the Sanggunian to ask questions from invited resource persons coming from both the government and private sectors, usually heads of offices, technical men and prominent individuals, primarily intended to seek information from the latter on certain matters that are of public interest;
