**RESOLUTION NO. 494-2023**

**DECLARING MUNICIPAL ORDINANCE NO. 03, S-2023 OF THE SANGGUNANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING SWIMMING ACTIVITIES AT THE BINMALEY BEACH OF THIS MUNICIPALITY AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Ordinance No. 03, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (iii) of R. A. No. 7160;


