APPROVING RESOLUTION NO. 44, S-2023 OF THE SANGGUNANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED “APPROVING RESOLUTION NO. 1, SERIES OF 2023 OF THE MUNICIPAL DEVELOPMENT COUNCIL, CALASIAO, PANGASINAN, ENTITLED “RESOLUTION RECOMMENDING APPROVAL OF THE REALIGNMENT/REVERSION OF THE AMOUNT OF SIX MILLION ONE HUNDRED SIXTY THREE THOUSAND SEVEN HUNDRED SIXTY ONE PESOS (P6,163,761.00) FROM THE PORTION OF UNUTILIZED FUND OF THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM 2022 (CONTINUING APPROPRIATIONS) PREVIOUSLY ALLOTTED TO THE FOLLOWING: ELEVATION AND CONCRETING OF FLOORING AT PUBLIC PLAZA (PHASE 1) P2,500,000.00; IMPROVEMENT OF CALASIAO PUBLIC PARKS AND PLAZA P1,313,761.00; RESTRUCTURING OF ELECTRICAL WORKS AND REPLACEMENT OF LIGHTS AT MULTI-PURPOSE BUILDING (CALASIAO SPORTS COMPLEX) P2,350,000.00 WITH A TOTAL AMOUNT OF P6,163,761.00, AND FROM ANNUAL INVESTMENT PROGRAM (AIP) OF 2023 AMOUNTING TO FIVE MILLION PESOS (P5,000,000.00) ALLOTTED TO CONSTRUCTION OF FOOD COURT”

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its SB Resolution No. 44, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Calasiao has proposed for the realignment/reversion of a sum of ₱11,163,761.00 from the 20% Development Fund (CYs 2022 and 2023) of the LGU. This was endorsed by the Council through MDC Resolution No. 1, Series of 2023 dated March 2, 2023 to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. The realigned/reverted amount will be used to augment the funds needed for the LGU's proposed/new development project, the Establishment and Construction of New Slaughterhouse at Barangay Mancup which are of the same expense class; and
3. The aforementioned project conforms with the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects), and was included in the Supplemental Investment Program for CY 2023 of LGU Calasiao.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. No. 44, S-2023 of the Sangguniang Bayan of Calasiao, Pangasinan, entitled “ Approving Resolution No. 1, Series of 2023 of the Municipal Development Council, Calasiao, Pangasinan, entitled “Resolution recommending approval of the realignment/reversion of the amount of Six Million One Hundred Sixty Three Thousand Seven Hundred Sixty One Pesos (P6,163,761.00) from the portion of unutilized fund of the Supplemental Annual Investment Program 2022 (Continuing Appropriations) previously allotted to the following: Elevation and Concreting of Flooring at Public Plaza (Phase 1) P2,500,000.00; Improvement of Calasiao Public Parks and Plaza P1,313,761.00; Restructuring of Electrical Works and Replacement of Lights at Multi-Purpose Building (Calasiao Sports Complex) P2,350,000.00 with a total amount of P6,163,761.00, and from Annual Investment Program (AIP) of 2023 amounting to Five Million Pesos (P5,000,000.00) allotted to Construction of Food Court”;


