### RESOLUTION NO. 683-2023

**DECLARING ORDINANCE NO. 011, S-2023 OF THE SANGGUNANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE ADOLESCENT PREGNANCY AND PREVENTION PROGRAM OF LINGAYEN AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 011, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 17 (a) (b) (2) (iv) and 447 (a) (5) (xiv) of R. A. No. 7160, Article II, Section 13 of the 1987 Philippine Constitution and Republic Act No. 5462 otherwise known as the “Manpower and Out-of-School Youth Development Act of the Philippines”;

**WHEREAS**, the Municipality of Lingayen shall include in the LGU’s Annual Budget for CY 2024 the funding for the Program on Adolescent Pregnancy and Prevention to effect the implementation of the subject ordinance;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Sections 59 (c) of R.A. No. 7160;


