## **RESOLUTION NO. 686-2023**

DECLARING MUNICIPAL ORDINANCE NO. 02, S-2023 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE PHILIPPINE PACKAGE OF ESSENTIAL NON-COMMUNICABLE DISEASES (NCDS) INTERVENTIONS (PHILPEN) ON THE INTEGRATED MANAGEMENT OF HYPERTENSION AND DIABETES FOR PRIMARY HEALTH CARE FACILITY IN THE MUNICIPALITY OF STO. TOMAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Municipal Ordinance No. 02, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iii) and 447 (a) (5) (xiv) of R. A. No. 7160; Section 15 of Article II & Section 11 of Article XIII of the 1987 Philippine Constitution; DOH Administrative Order 2011-0003, entitled "National Policy on Strengthening the Prevention and Control of Chronic Lifestyle Related Non-Communicable Diseases; DOH Administrative Order No. 2012-0029, entitled "Implementing Guidelines on the Institutionalization of Philippine Package of Essential NCG Interventions (PHILPEN) on the Integrated Management of Hypertension and Diabetes for Primary Health Care Facilities" and DOH Administrative Order No. 2010-0036, entitled "The Aquino Health Agenda: Achieving Universal Health Care for All Filipinos";
