**APPROVING RESOLUTION NO. 2023-222 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 3, FOR THE CALENDAR YEAR 2023 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2023-222 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Balungao, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No.3. This was endorsed to the Sangguniang Bayan for approval on May 15,2023 by the Municipal Development Council thru Resolution No.2023-04;
2. Said SAIP No. 3 of the municipality with an investment requirement of Php646,556.20 covers the implementation of programs/projects to be funded from the municipality’s shares from the Philippine Charity Sweepstakes (Lotto and STL Shares from the Charity Fund and Calamity Assistance) as per EO 357 and further amended by EO 357- A “Allocation of 5% Share for Local Government Units from the Lotto Charity Fund and Providing a Sharing Scheme Therefor”; and


