

CONTRACT AGREEMENT

This AGREEMENT made this 16th day of February 2024 between the **PROVINCIAL GOVERNMENT OF PANGASINAN**, of the Philippines (hereinafter called the "Procuring Entity") of the one part and **R.T. MACANLALAY CONSTRUCTION** (hereinafter called the "Contractor/Supplier") of the other part;

WHEREAS, the Entity is desirous that the Contractor execute **Concreting of Farm to Market Road at Barangay Reynado, Bayambang, Pangasinan; Excise Tax; PR No. 2024-01-0063; Solicitation No. PANG-2024-01-0030-CW**, and the Entity has accepted the Bid for **Four Million, Five Hundred Eighty-Five Thousand, Four Hundred Eighty-Six Pesos and 88/100 Only (P4,585,486.88)** by the Contractor for the execution and completion of such Works and to remedy any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder' response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation.
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by the existing laws and/or the Procuring Entity concerned in the PBD's. **Winning bidder agrees that the additional contract documents or information prescribed by the contract execution, such as the Notice to Proceed, Variation Orders, and warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Four Million, Five Hundred Eighty-Five Thousand, Four Hundred Eighty-Six Pesos and 88/100 Only (P4,585,486.88)** or such other sums as may be ascertained, **R.T. MACANLALAY CONSTRUCTION** agrees to the **Concreting of Farm to Market Road at Barangay Reynado, Bayambang, Pangasinan; Excise Tax; PR No. 2024-01-0063; Solicitation No. PANG-2024-01-0030-CW**, in accordance with his/her/its Bid.
