RESOLUTION NO. 165-2024

DECLARING ORDINANCE NO. 2023-24 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO) OF THE LOCAL GOVERNMENT OF THE CITY OF ALAMINOS, PANGASINAN AND CREATING THE POSITION OF CITY ENVIRONMENT AND NATURAL RESOURCES OFFICER 1 TO HEAD THE OFFICE AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2023-24 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76, 454 (b) (c), 458 (a) (1) (vi) (viii) & 447 (a) (1) (viii) of R. A. No. 7160”;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2023-24 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled “An Ordinance establishing the City Environment and Natural Resources Office (CENRO) of the Local Government of the City of Alaminos, Pangasinan and creating


