RESOLUTION NO. 169-2024

APPROVING RESOLUTION NO. 143-2023 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 3 FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN”

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Resolution No. 143-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Burgos, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 3 CY 2023. This was endorsed to the Sangguniang Bayan on December 1, 2023 through MDC Resolution No. 2023-05;
2. Said SAIP No. 3 covers fund augmentation for Personal Services (granting of Performance Based Bonus and Service Recognition Incentives to qualified employees), Maintenance and Other Operating Expenses of some municipal offices, and the payment of loan amortization of the LGU; and

3. Funding support for the full implementation of the said SAIP, with a total investment requirement of Php6,740,014.00, is embodied in the municipality's Supplemental Budget No. 03 CY 2023, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03-2023 on December 4, 2023.


