RESOLUTION NO. 179-2024

APPROVING RESOLUTION NO. 137, S-2023 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 4 CY 2023"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 137-S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Aguilar, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 4 for FY 2023. This was endorsed by the Council, through MDC ExeCom Resolution No. 9, S2023 dated December 14, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental AIP, which has a total investment requirement of ₱6,102,650.00, covers the augmentation of funds for Personal Services (granting of Collective Negotiation Agreement Incentive and Service Recognition Incentive to qualified municipal employees), Maintenance and Other Operating Expenses (Gratuity Pay to Job Order Workers) and implementation of Disaster Risk Reduction Programs and other priority projects of the LGU. The proposed projects to be funded from the 5%

LDRRM Fund are based on Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund); and

3. Funding for the implementation of the LGU's Supplemental AIP is embodied in their Supplemental Budget No. 4 for FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 05, Series of 2023 dated December 18, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Aguilar, Pangasinan;
