RESOLUTION NO. 184-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2023 OF BUGALLON, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P14,141,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Supplemental Budget No. 2, for Calendar Year 2023 involving total appropriations of Php14,141,000.00, which was enacted on December 21, 2023 through Appropriation Ordinance No. 2023-01;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. That the reversion of savings from the Personal Services (PS) and Maintenance & Other Operating Expenses (MOOE) shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);

3. That the grant of Other Personnel Benefits-Collective Negotiation Agreement (CNA) Incentive for FY 2023 to government employees shall be in accordance with the provisions of Budget Circular No. 2023-1 dated November 10, 2023 of the Department of Budget and Management;
4. That the grant of Other Personnel Benefits - Service Recognition Incentive (SRI) to government employees for Fiscal Year 2023 shall be in accordance with the provisions of Budget Circular No. 2023-2 dated December 13, 2023 by the Department of Budget and Management; and
5. That the grant for Gratuity Pay to Contract of Service and Job Order Workers in Government for FY 2023 of the municipality shall be in accordance with the provisions of Budget Circular No. 2023-3 dated December 14, 2023.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in Its Entirety the Supplemental Budget No. 2, for Calendar Year 2023 of Bugallon, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bugallon, Pangasinan, for its information and guidance.
