**RESOLUTION NO. 221-2024**

**DECLARING ORDINANCE NO. 2023-029 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING ADOLESCENT PREGNANCY AND REDUCTION PROGRAM CUM TEEN CENTER OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Ordinance No. 2023-029 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 17 (a) (b) (2) (iv) and 447 (a) (5) (xiv) of R.A. No. 7160; Article II, Section 13 of the 1987 Philippine Constitution; Republic Act No. 5462 otherwise known as the Manpower and Out-of-School Youth Development Act of the Philippines;

**WHEREAS**, it is now incumbent on the part of the Local Chief Executive in coordination with the Municipal Local Finance Committee to provide an appropriation for the implementation of the subject ordinance.
