RESOLUTION NO. 225-2024

DECLARING MUNICIPAL ORDINANCE NO. 2023-008 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “AN ORDINANCE MANDATING THE ENFORCEMENT OF PRE-EMPTIVE AND FORCED EVACUATION DURING EMERGENCY SITUATIONS CAUSED BY NATURAL OR MAN-MADE DISASTERS IN THE MUNICIPALITY OF LAOAC, PANGASINAN AND PROVIDING GUIDELINES THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Ordinance No. 2023-008 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer has conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 11 (b) (1) (2) (3) of RA 10121, otherwise known as the “Philippine Disaster Risk Reduction and Management Act of 2010; Department of Interior and Local Government (DILG) Memorandum Circular No. 2012-35 dated February 24, 2012 and Sections 16 & 447 (a) (iv) of R.A. No. 7160”;
