PROVINCIAL RESOLUTION NO. 285-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE ILOCOS TRAINING AND REGIONAL MEDICAL CENTER FOR THE IMPLEMENTATION OF THE NURSING SKILLS TRAINING PROGRAM IN THE PROVINCE

WHEREAS, the Nursing Skills Training Program is a training program offered by the Ilocos Training and Regional Medical Center (ITRMC) composed of various nursing specializations such as PeriOperative Nursing Skills Training Program, Maternal Health Skills Training Program, Pediatric Nursing Skills Training Program, Neonatal Nursing Competency Enhancement Program, Basic Emergency & Trauma Nursing Skills Enhancement Program, Basic Critical Care Nursing, and Basic Orthopedic Rehabilitation Nursing;

WHEREAS, the Nursing Skills Training Program, that is being offered by ITRMC to the Province of Pangasinan, aims to equip and enhance the knowledge and clinical skills of the nurses in the Province;

WHEREAS, the Provincial Government of Pangasinan, through the Pangasinan Provincial Hospital, in partnership with the Ilocos Training and Regional Medical Center will join efforts in conducting the said notable program;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Ilocos Training and Regional Medical Center, represented by Dr. Eduardo M. Badua III, Medical Center Chief;

WHEREAS, the duties and responsibilities of each party in the implementation of the program are already defined in the MOA;
