APPROVING RESOLUTION NO. 2023-196 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 6, C.Y. 2023 OF SUAL, PANGASINAN AMOUNTING TO FIFTEEN MILLION FIFTY THOUSAND PESOS (P15,050,000.00)”

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2023-196 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 6 for CY 2023. This was endorsed to the Sangguniang Bayan for approval on November 30, 2023 by the Municipal Development Council thru Resolution No. 8, Series of 2023;
2. The SIP No. 6 covers fund augmentation for Personal Services (granting of Collective Negotiation Agreement Incentive and Service Recognition Incentive to qualified employees), Maintenance and Other Operating Expenses and, Capital Outlay of some municipal government offices; and

3. Funding support for the implementation of the same in the amount of PhP15,050,000.00 is embodied in their proposed Supplemental Budget No. 06 CY 2023 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 07, CY 2023 on December 11, 2023.


