APPROVING MUNICIPAL RESOLUTION NO. 127-2023 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 02 FOR CY 2023 OF THE MUNICIPALITY OF NATIVIDAD, PANGASINAN AMOUNTING TO SEVEN MILLION FOUR HUNDRED EIGHTY FIVE THOUSAND SIX HUNDRED THIRTY THREE PESOS AND EIGHTEEN CENTAVOS (P7,485,633.18)”

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Municipal Resolution No. 127-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Natividad, Pangasinan has identified items in their Supplemental Annual Investment Program No. 02 for CY 2023. This was endorsed to the Sangguniang Bayan on November 16, 2023 through MDC Executive Committee Resolution No. 03-2023;
2. The SAIP No. 02 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses (MOOE) of some offices in the LGU and the implementation of priority programs of LGU Natividad; and

- Funding support for the proposed SAIP No.02, with a total investment requirement of PHP7,485,633.18 is embodied in the municipality's Supplemental Budget No. 02-2023, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03-2023 on November 24, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Natividad, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Municipal Resolution No. 127-2023 of the Sangguniang Bayan of Natividad, Pangasinan, entitled “Approving the Supplemental Annual Investment Program (AIP) No. 02 for CY 2023 of the Municipality of Natividad, Pangasinan amounting to Seven Million Four Hundred Eighty Five Thousand Six Hundred Thirty Three Pesos and Eighteen Centavos (P7,485,633.18)”;
