APPROVING MUNICIPAL RESOLUTION NO. 133-2023 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 03 FOR CY 2023 OF THE MUNICIPALITY OF NATIVIDAD, PANGASINAN AMOUNTING TO TWO MILLION THREE HUNDRED SIXTEEN THOUSAND FIVE HUNDRED PESOS (P2,316,500.00)”

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Municipal Resolution No. 133-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council (Executive Committee) of Natividad, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 03 for CY 2023. This was endorsed to the Sangguniang Bayan on December 13, 2023 through MDC Resolution No. 04-2023;
2. The SAIP No. 03 of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive (SRI) to qualified officials and employees of LGU Natividad) and Maintenance and Other Operating Expenses (MOOE) of some municipal offices; and

3. Funding support for the proposed SAIP, with a total investment requirement of PhP2,316,500.00 is embodied in the municipality's Supplemental Budget No. 03-2023, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 04-2023 on December 18, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Natividad, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 133-2023 of the Sangguniang Bayan of Natividad, Pangasinan, entitled “Approving the Supplemental Annual Investment Program (AIP) No. 03 for CY 2023 of the Municipality of Natividad, Pangasinan amounting to Two Million Three Hundred Sixteen Thousand Five Hundred Pesos (P2,316,500.00)”;
