### PROVINCIAL ORDINANCE NO. 330-2024

#### AN ORDINANCE ESTABLISHING THE PANGASINAN GOVERNMENT UNIFIED INCENTIVES FOR MEDICAL CONSULTATION PROGRAM AND APPROPRIATING FUNDS THEREFOR

**WHEREAS**, Section 15, Article II of the 1987 Constitution of the Republic of the Philippines declares that "The State shall protect and promote the right to health of the people and instill health consciousness among them";

**WHEREAS**, Section 17(b)(2)(iii) of the Local Government Code of 1991 (Republic Act No. 7160) mandates that provincial governments shall be responsible for the implementation and provision of health services, including hospitals, health centers, and other health-related services, within their jurisdiction;

**WHEREAS**, Republic Act No. 11223, otherwise known as the "Universal Health Care Act," aims to ensure that all Filipinos are guaranteed equitable access to quality and affordable healthcare services, while also emphasizing the role of local government units (LGUs) in improving health outcomes at the community level. As such, Section 6 (a) thereof, provides that "Every Filipino shall be granted immediate eligibility and access to preventive, promotive, curative, rehabilitative, and palliative care for medical, dental, mental and emergency health services, delivered either as population-based or individual-based health services".

**WHEREAS**, the Province of Pangasinan recognizes the importance of health as a fundamental human right and a critical component of social and economic development;

**WHEREAS**, PhilHealth and other relevant agencies have initiated various programs aimed at improving health outcomes, but there remains a need for a more focused and localized approach to address the specific health needs of the people of Pangasinan;

**WHEREAS**, in consonance with PhilHealth Circular No. 2023-0013, entitled: "Implementing Guidelines for the PhilHealth Konsultasyong Sulit at Tama (PhilHealth Konsulta) Package (Revision 2)", the constituents are encouraged to register and avail of the said benefit;

**NOW, THEREFORE**, on motion of SP Member Shiela Marie F. Baniqued and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded-

*Be it ordained by the Province of Pangasinan, in Regular Session assembled:*

**SECTION 1. SHORT TITLE** – This ordinance shall be known as the **"PANGASINAN GOVERNMENT UNIFIED INCENTIVES FOR MEDICAL CONSULTATION PROGRAM"**.

**SECTION 2. PURPOSES** – This Ordinance shall have the following purposes:

1. To encourage regular health consultations, check-ups, and preventive care of all individuals in the province, especially among indigent families;
2. To improve health-seeking behaviors, reduce the incidence of preventable diseases, and ensure that the people of Pangasinan have access to quality healthcare services;
3. To support the attainment of the purposes of the Universal Healthcare Law and the PhilHealth Konsultasyong Sulit at Tama (Konsulta) Program;
4. To provide financial assistance for the people of Pangasinan to be able to avail of regular health consultations, check-ups, preventive care, and to incentivize the regular availment of such services;

**SECTION 3. SCOPE AND COVERAGE** -This Ordinance shall cover all individuals who shall:

1. Register for PhilHealth Konsulta at the Fourteen (14) Government Hospitals of the Provincial Government of Pangasinan, namely:

2. Avail of the services of PhilHealth Konsulta.

**SECTION 4. UNIFIED INCENTIVES PROGRAM** – A unified incentives program is hereby established for the availment of PhilHealth Konsulta, which may consist of any or a combination of the following:

1. Provision of Free Medicines, Vitamins, and Supplements - Individuals who avail of PhilHealth Konsulta will be provided free vitamins, and supplements, according to their needs, apart from the PhilHealth Konsulta Package 21 Molecules (Amoxicillin, Co-Amoxiclav, Cotrimoxazole, Nitrofurantoin, Ciprofloxacin, Clarithromycin, Oral Rehydrating Solution, Prednisone, Salbutamol, Fluticasone + Salmeterol, Paracetamol, Gliclazide, Metformin, Simvastatin, Enalapril, Metoprolol, Amlodipine, Hydrochlorothiazide, Losartan, Aspirin, Chlorphenamine maleate).
2. Cash Incentives – Individuals who register for PhilHealth Konsulta shall receive a cash incentive for registration, and additional cash incentives for every consultation and/or availment of medical services;
3. Food Assistance – Individuals who avail of PhilHealth Konsulta may be provided with meals or other food assistance during their visit.
4. Transportation Assistance – Individuals intending to avail of PhilHealth Konsulta may be provided with transportation assistance thru the use of the vehicles of the Province of Pangasinan.

**SECTION 5. AUGMENTATION OF CAPACITY** – The Provincial Government of Pangasinan shall augment the capacity of its 14 Government Hospitals by providing any or a combination of the following:

1. Human Resource – Additional human resource to address the increased number of individuals availing of the PhilHealth Konsulta;
2. Equipment – Additional medical, operational, and administrative equipment to address the increased number of individuals availing of the PhilHealth Konsulta;
3. Medicine, Vitamins, and Supplements – Additional medicine, vitamins, and supplements to address the increased number of individuals availing of the PhilHealth Konsulta.

**SECTION 6. IMPLEMENTING OFFICE** – The Provincial Health Management Services Office in coordination with the Provincial Health Office, and other concerned offices shall convene and formulate the Implementing Rules and Regulations (IRR) for this Ordinance.

**SECTION 7. FUNDING** – The amount necessary to carry out the provisions of this Ordinance shall be appropriated in the Annual Budget or the Supplemental Budget.

**SECTION 8. SEPARABILITY CLAUSE** – In the event any of the provisions of this ordinance is declared void or unenforceable by final judgment of a court of competent jurisdiction, the other provisions unaffected thereby shall remain in full force and effect.

**SECTION 9. REPEALING CLAUSE** – Any issuance, executive order, administrative order, proclamation, charter, rule or regulation and/or parts thereof contrary to or inconsistent with the provisions of this ordinance is hereby repealed, modified or amended accordingly.

**SECTION 10. EFFECTIVITY** – This Ordinance shall take effect upon approval of the Sanggunian.
