APPROVING RESOLUTION NO. 122-2023 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL NO. 3 OF THE ANNUAL INVESTMENT PROGRAM, CALENDAR YEAR 2023 OF THE MUNICIPALITY OF AGNO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Resolution No. 122-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Agno, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 3 CY 2023. This was endorsed to the Sangguniang Bayan for approval on October 6, 2023 by the Municipal Development Council – Executive Committee thru Resolution No. 03-2023;
2. The Supplemental Investment Program (SIP) No. 3 covers fund augmentation for the Maintenance and Other Operating Expenses of various offices of the LGU and the implementation of disaster risk reduction and management programs/projects and various development projects of the municipal government;

3. Funding support for the implementation of the same in the amount of PhP11,515,845.40 is embodied in the proposed Supplemental Budget No. 2 for Calendar Year 2023 which was enacted by the Sangguniang Bayan thru Appropriation Ordinance No. 2, Series of 2023 on October 16, 2023. Included in this SIP however are disaster risk reduction and management programs proposed to be funded from the unexpended balances of the LGU's LDRRM Fund in 2021 and 2022. Section 6.5 of NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013, "Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF)" provides that: "The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMF".

WHEREAS, the implementation of the programs/projects to be funded under the LDRRMF is not approved, as this is not in accordance with Item Nos. 6.4 & 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Agno, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—
