APPROVING RESOLUTION NO. 130-2023 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL NO. 4 OF THE ANNUAL INVESTMENT PROGRAM, CALENDAR YEAR 2023 OF THE MUNICIPALITY OF AGNO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Resolution No. 130-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Agno, Pangasinan has identified items in their Supplemental Investment Program (SIP) No.4 CY 2023. This was endorsed to the Sangguniang Bayan for approval on October 20, 2023 by the Municipal Development Council – Executive Committee thru Resolution No. 04-2023;
2. The Supplemental Investment Program (SIP) No. 4 covers fund augmentation for Personal Services (granting of Service Recognition Incentive to qualified employees of the LGU), Maintenance and Other Operating Expenses, and Capital Outlays of various offices of the LGU and the implementation of various projects of the municipal government; and

3. Funding support for the implementation of the same in the amount of PhP5,233,607.00 is embodied in their proposed Supplemental Budget No. 3 for Calendar Year 2023 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No.3 Series of 2023 on October 23, 2023 and approved by the Municipal Mayor on October 25, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Agno, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—


