INVITING POLICE COLONEL JEFF E. FANGED, PROVINCIAL DIRECTOR, PANGASINAN POLICE PROVINCIAL OFFICE, AND POLICE LIEUTENANT COLONEL AMOR MIO SOMINE, CHIEF OF POLICE, LINGAYEN MUNICIPAL POLICE STATION, BOTH OF THE PHILIPPINE NATIONAL POLICE, AND ATTY. EMMANUEL E. LAFORTEZA, OIC PROVINCIAL PROSECUTOR, QUESTION **HOUR** OF THE **SANGGUNIANG** PANLALAWIGAN OF PANGASINAN ON ITS OCTOBER 7, 2024 REGULAR (PHYSICAL) SESSION TO APPRISE THE AUGUST BODY ON THE PEACE AND ORDER SITUATION OF THE PROVINCE OF PANGASINAN IN RELATION TO THE RECENT KILLING INCIDENT AT THE LINGAYEN BEACHFRONT

WHEREAS, the Sangguniang Panlalawigan is deeply concerned and alarmed over the death of a 20-year old woman whose body was found half-buried in sand along the Lingayen Baywalk on Tuesday evening, September 24, 2024;

WHEREAS, Miss Evalend Cervera Salting, who hails from Barangay Sabling, Anda, Pangasinan, and a 3rd Year Business Administration student of the Pangasinan State University-Lingayen Campus, had been reported missing on Monday night, September 23, 2024;

WHEREAS, the Sangguniang Panlalawigan is condemning in the strongest possible terms the merciless killing of Miss Evalend Cervera Salting who was found along the beach area of Lingayen;

WHEREAS, this inhumane and senseless act of violence cannot be allowed to pass without any action being undertaken by the Provincial Government of Pangasinan through the Sangguniang Panlalawigan;

> WHEREAS, there is a need therefore to conduct a Question Hour in order to assess the current peace and order situation of the Province of Pangasinan with the end in view of establishing the appropriate measures and solutions to reduce and/or to prevent the incidence of crimes, lawlessness and other illegal activities in the locality;

> WHEREAS, the Sangguniang Panlalawigan as the highest legislative body of the Province is empowered to conduct an inquiry on certain matters that are of public interest, in aid of legislation;

> WHEREFORE, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco, duly seconded, it was –

> **RESOLVED**, by the Sangguniang Panlalawigan in session assembled to invite, as they are hereby invited, Police Colonel Jeff E. Fanged, Provincial Director, Pangasinan Police Provincial Office, and Police Lieutenant Colonel Amor Mio Somine, Chief of Police, Lingayen Municipal Police Station, both of the Philippine National Police, and Atty. Emmanuel E. Laforteza, OIC Provincial Prosecutor, to a Question Hour of the Sangguniang Panlalawigan of Pangasinan on its October 7, 2024 Regular (Physical) Session to apprise the august Body on the peace and order situation of the Province of Pangasinan in relation to the recent killing incident at the Lingayen Beachfront;
