#### **RESOLUTION NO. 907-2024**

APPROVING RESOLUTION NO. 08-24-293 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM 2 (SIP 2) SERIES OF 2024 OF THE LGU MABINI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Resolution No. 08-24-293 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Mabini, Pangasinan has identified items in their Supplemental Investment Program 2 for CY 2024. This was endorsed to the Sangguniang Bayan on August 19, 2024 through MDC (Execom) Resolution No. 03, Series of 2024;
- 2. The SIP No. 2 of the municipality covers fund augmentation for Personal Services (First Tranche of the Updated Salary Schedule), Maintenance and Other Operating Expenses of some municipal government offices, and the implementation of disaster risk reduction and management programs/projects of the LGU; and

3. Funding support for the proposed SIP, with a total investment requirement of PhP5,183,827.53 is embodied in the municipality's Supplemental Budget No. 2 FY 2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2, Series of 2024 on August 27, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mabini, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
