APPROVING RESOLUTION NO. 2024-120A OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 4 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF LAOAC, PANGASINAN IN THE TOTAL AMOUNT OF EIGHT HUNDRED FIFTY-NINE THOUSAND FIVE HUNDRED TWENTY-SEVEN PESOS & 77/100 (P859,527.77)”

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 2024-120A to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Laoac, Pangasinan has identified items in their 4th Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan for approval on August 2, 2024 by the Municipal Development Council-Executive Committee through Resolution No. 2024-01;
2. The SAIP covers fund augmentation for the Personal Services (First Tranche of the Modified Salary Schedule); and

3. Funding support for the full implementation of the same is embodied in their proposed Supplemental Budget No. 4 for CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-004 on August 5, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Laoac, Pangasinan;


