RESOLUTION NO. 898-2024

DECLARING SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2024 OF BINMALEY, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P77,886,706.63, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2024 involving total appropriations of P77,886,706.63, which was enacted on June 27, 2024 through Appropriation Ordinance No. 1, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. No. 7160 (Use of Appropriated Funds and Savings);

- 3. That the utilization of appropriations from 20% Development Fund shall be in accordance with the provisions of DBM DOF DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re "Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects";
- 4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
- 5. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program of the municipality and its Supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007; and
- 6. That the procurement of vehicle shall be subject to the provisions of Budget Circular No. 2022 1 of the Department of Budget and Management dated February 11, 2022 re "Omnibus Guidelines on the Acquisition, Use, Rental, and Replacement of Government Motor Vehicles".

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 1 for Calendar Year 2024 of Binmaley, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Binmaley, Pangasinan, for its information and guidance.
