**RESOLUTION NO. 337-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 2024-02 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “AN ORDINANCE ABOLISHING ONE VACANT POSITION AND CREATING TEN NEW POSITIONS IN THE MUNICIPALITY OF BUGALLON, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2024-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R. A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2024-02 of the Sangguniang Bayan of Bugallon, Pangasinan, entitled “An Ordinance abolishing one vacant position and creating ten new positions in the Municipality of Bugallon, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;




