**RESOLUTION NO. 385-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 2023-014 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "THE COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS IN THE MUNICIPALITY OF LAOAC, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Laoac, Pangasinan submitted its Municipal Ordinance No. 2023-014 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132 & 447 (3) (i) of R. A. No. 7160 and Section 11(f) of Republic Act No. 11032, or the "An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services";

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2023-014 of the Sangguniang Bayan of Laoac, Pangasinan, entitled "The collection of corresponding barangay clearance fee in the application for any business-related transactions in the Municipality of Laoac, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
