RESOLUTION NO. 399-2024

DECLARING MUNICIPAL ORDINANCE NO. 14, S-2023 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE PROGRAMS, SERVICES, PRIVILEGES AND BENEFITS FOR SOLO PARENTS AND THEIR CHILDREN, APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES PURSUANT TO REPUBLIC ACT 8972, KNOWN AS THE SOLO PARENT ACT OF 2000” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Municipal Ordinance No. 14-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iv) of R. A. No. 7160; R.A. No. 8972, otherwise known as the “Solo Parents Welfare Act of 2000”; and R.A. No. 11861 or the “Expanded Solo Parents Welfare Act”;

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of R. A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


