PROVINCIAL RESOLUTION NO. 418-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES FOR THE INSTALLATION OF AN ADDITIONAL AUTOMATED TELLER MACHINE (ATM) TO BE LOCATED AT THE PROVINCIAL CAPITOL COMPOUND PARTICULARLY AT THE LEGISLATIVE BUILDING

WHEREAS, the Land Bank of the Philippines is the primary depository bank of the Province of Pangasinan and it is a partner of the provincial government in promoting countryside development;

WHEREAS, there are two (2) Automated Teller Machines (ATMs) installed within the premises of the Capitol Compound but which are not enough to service the officials and employees of the provincial government including individuals residing or working in nearby surroundings of the area;

WHEREAS, an additional ATM unit of the Land Bank of the Philippines is therefore, needed to service the Provincial Government and its nearby clientele;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Honorable Governor Ramon V. Guico III, and the Land Bank of the Philippines, represented by Atty. Benizar C. Francisco, Assistant Vice President/Head of Field Support Services Center I;


