**PROVINCIAL RESOLUTION NO. 424-2024**

**ENDORING TO THE DEPARTMENT OF HEALTH THE APPLICATION FOR A PERMIT TO CONSTRUCT INFRASTRUCTURE PROJECTS AT THE PANGASINAN PROVINCIAL HOSPITAL, PROVINCE OF PANGASINAN**

**WHEREAS**, the Pangasinan Provincial Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 3<sup>rd</sup> District of Pangasinan;

**WHEREAS**, the hospital's statistics would show that there is a constant increase in the number of patients being serviced by the hospital;

**WHEREAS**, the Provincial Government of Pangasinan, through the Pangasinan Provincial Hospital, intends to convert an old pharmacy into an MRI Room and the repair/rehabilitation of its Radiology Complex;

**WHEREAS**, the Pangasinan Provincial Hospital shall also convert 7 bed ward rooms and treatment room into a pharmacy;

**WHEREAS**, in line with the main thrusts of the present administration to have a mass-based health care program to accommodate all people especially the less fortunate sector of society, there is a need to support the plan of the Pangasinan Provincial Hospital to provide a more sufficient and higher level of medical and health services to its patients through the implementation of the infrastructure projects;

**WHEREAS**, prior to the issuance of a license to construct, a Provincial Board Resolution is required by the Department of Health to facilitate the issuance of the permit to construct a health facility;

**WHEREFORE**, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


