#### PROVINCIAL RESOLUTION NO. 432-2024

REALIGNING THE FOUR HUNDRED MILLION PESOS (P400 MILLION) PORTION OF THE LAND BANK OF THE PHILIPPINES' LOAN ORIGINALLY INTENDED FOR TERM LOAN 47 FOR THE ALLOCATION OF ADDITIONAL FUNDS UNDER TERM LOANS 43 AND 45

WHEREAS, in pursuant to Provincial Ordinance No. 312-2023, the Provincial Government of Pangasinan has availed of the Omnibus Term Loan Facility with the Land Bank of the Philippines to finance strategic programs and projects for the Province;

**WHEREAS**, the amount of P600 Million is a portion of the Omnibus Term Loan Facility under Term Loan 47 primarily intended to finance the Construction of Bolinao Airport Support Facilities, but the same has not yet been availed of by the Province;

**WHEREAS**, there is a need to realign a portion of the said loan amounting to P400 Million to be used for the allocation of additional funds of P200 Million each under Term Loans 43 and 45, as follows:

Term Loan 43	To finance the Construction of Eleven (11) Storey Government
	Center in the amount of Two Billion Only (P2,000,000,000.00) or
	contract price, whichever is lower, but not to exceed the Net
	Borrowing Capacity as certified by the Bureau of Local
	Government Finance.
Term Loan 45	To finance the Redevelopment of Capitol Complex in the amount
	of Seven Hundred Million Only (P700,000,000.00) or contract
	price, whichever is lower, but not to exceed the Net Borrowing
	Capacity as certified by the Bureau of Local Government Finance.

**RESOLVED,** by the Sangguniang Panlalawigan in session assembled, to realign, as it is hereby realigned, the Four Hundred Million Pesos (P400 M) portion of the Land Bank of the Philippines' loan originally intended for Term Loan 47 for the allocation of additional funds under Term Loans 43 and 45;

**RESOLVED, FINALLY**, that copies of this resolution be furnished to the Provincial Governor, Ramon V. Guico III, the Provincial Accountant, the Provincial Budget Officer, the Provincial Treasurer, the Provincial Auditor, and the Land Bank of the Philippines, for their information and guidance.
