RESOLUTION NO. 443-2024

**DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR
CALENDAR YEAR 2023 OF SAN FABIAN, PANGASINAN
INVOLVING A TOTAL APPROPRIATION OF P1,222,837,83,
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2023 involving total appropriations of Php1,222,837.83 which was enacted on December 6, 2023 through Appropriation Ordinance No. 3, S-2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the disbursement of appropriation for Performance Based Bonus (PBB) for FY 2022 shall be in accordance with the provisions of Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring Information and Reporting Systems Memorandum Circular No. 2023-1 dated August 22, 2023; and
2. That the reversion from Personal Services savings shall be in accordance with the provisions of Section 336 of R. A. No. 7160 (Use of Appropriated Fund & Savings).


